

## SFI CHAIN OF CUSTODY CERTIFICATIONS - PRINTERS ONLY

The following organizations are certified to Section 3 of the SFI 2010-2014 Requirements for the SFI 2010-2014 Program –SFI Chain of Custody Standard, which means they can track wood fiber through the different stages of production. Once chain-of-custody certified, companies can make claims about how much of their product comes from certified lands, how much contains post-consumer recycled content, and how much is responsibly sourced fiber. These claims can be made based on either the physical separation or percentage-based methods.
