


Forest Certification UPDATE



Domtar Paper Company, LLC **SFIS 2010 - 2014**

Domtar Paper Company, LLC operations are located in the United States and Canada and have a central office function for this certification located in Fort Mill, South Carolina. The company's Sustainable Forest Management program has been registered to the SFI Standard since October 15, 2004 and has undergone annual 3rd party surveillance audits since the date of initial registration.

BACKGROUND

During the period of July 27 -28; August 26; and September 24 – 25, 2015 the Domtar Paper Company, LLC underwent a 24 month surveillance audit to the Sustainable Forestry Initiative (SFI®) Standard 2010-2014. The registration cycle is over 3 years with surveillance audits conducted annually. This report summarizes the audit process and results of the SAI Global surveillance audit.

SCOPE OF CERTIFICATION

Procurement of fiber from Alabama, Arkansas, Connecticut, Delaware, Florida, Georgia, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Maryland, Massachusetts, Michigan, Minnesota, Mississippi, Missouri, Nebraska, New Hampshire, New Jersey, New York, North Carolina, North Dakota, Ohio, Oklahoma, Pennsylvania, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, Vermont, Virginia, West Virginia, Wisconsin, Quebec, New Brunswick, Ontario, Manitoba, and British Columbia. – Objectives 8 – 20.

EXECUTIVE SUMMARY

The SFI Program third-party re-registration was undertaken by SAI Global. SAI Global is an independent third party registrar that is accredited by the ANSI-ASQ National Accreditation Board (ANAB) for registrations to SFIS 2010-2014. This ensures the integrity and credibility of the audit process.

The audit assessed conformity by interviewing Domtar procurement foresters, contractors, and suppliers; as well as observing the results of harvesting, road maintenance and construction, and silvicultural activities, as applicable, on harvest operations associated with the Rothschild, WI, USA and Windsor, PQ, Canada mills. The audit also assessed the SFIS documentation and records at the two mill offices and the Fort Mill, SC office.

THE AUDITORS

The SAI Global audit team who performed the audit consisted of Ms. Lynn Penniman CEP, EMS (LA) and Fabrice Lantheaume, MSc. Forestry.

KEY AREAS OF NON-CONFORMANCE

None identified.

For Rothschild Mill: PM 10.1, Indicator 1 - Consider formalizing requirements for use of trained loggers, especially under what circumstances and for what length of time “untrained” loggers can be used.
