Dear Rick:

The USGBC's revision of LEED has clearly generated significant interest among the many stakeholders involved in green building over the years. The revision has also sparked a lot of passion, which was driven home for us soon after we launched an online petition calling on USGBC to open LEED to all credible forest certification standards, including the Sustainable Forestry Initiative (SFI), the American Tree Farm System (ATFS), Canadian Standards Association (CSA) and the Programme for the Endorsement of Forest Certification (PEFC). SFI launched the petition after receiving numerous inquiries from individuals and groups around the world who care deeply about sustainable forestry and green building who wanted to know what they could do to express their views. We referred them to the USGBC website to comment and register to vote on the standard, but we also wanted to provide other ways to voice their concerns and demonstrate their support for a fair and inclusive green building program.

The petition, which is enclosed, has stimulated a tremendous outpouring of support, tapping into a broad and diverse community from across North America and countries around the world. Since its launch on March 16, nearly 6,000 have signed on, joining with forestry and sustainability experts who recognize these standards and their crucial role in promoting responsible forestry. While many of the signatories are not part of the official process and will not be casting votes, they want their voices heard on this important issue that directly impacts their communities, their forests, their families and their jobs. These are people who want to set aside the politics and instead focus on the facts and work with the USGBC to create a program that recognizes the value that all credible forest certification programs bring. Considering the staggering number of responses in the petition, you will not have time to read them all, so here are just a few:

There is no doubt that SFI has established credible standards supporting best management practices in forestry along with verifiable data. It is time for science and verifiable data to drive the certification. Good forestry follows good markets as data will show. We will plant, grow, harvest, and replant as the market grows. This will enhance clean air, clean water, wildlife and all the supports of our quality of life. As 2009 National Tree Farmer of the Year and 2010 Governor's Agricultural Stewardship Award winners, Earl and I know firsthand how important sustainability, stewardship and conservation are to our industry, state and nation. As a professional forester, forest manager and one who is involved in forest resources research, I can think of no reason the SFI and ATFS forest certification programs should not be accepted and recognized by LEED as respected and creditable standards for the purpose and goals set forth by LEED. I do support full recognition of all forest certification systems in LEED. I have performed research on the impacts of FSC and SFI and forest management and those findings consistently find that both systems improve forest management, and are quite similar in their overall effect of doing so. There is no empirical evidence to support favoring one system over another, and both improve forestry in the country. Thus both should be recognized equally. I agree with this petition. The CSA, SFI and PEFC standards for sustainable forest management, with which I am familiar, are equally demanding as the FSC and certainly environmentally equivalent to it. Those standards, too, have been developed by qualified and reputable individuals and have demonstrated their effectiveness over their years of application. (Peter J.
